4a (Code: ) (Expenses \$ 192,752. including grants of \$ ) (Revenue \$ ) Forest Field The Forest Field Program advocates for sustainable and ecologically sound management of public forests in the Pacific Northwest. In the past year, we have been active in the Okanogan-Wenatchee National Forest to better integrate aquatic conservation and to gain broader application of landscape evaluations to restore forest resilience. We also engaged in the Colville National Forest to formulate a Draft Forest Plan that emphasizes ecological restoration, road density standards, and the importance of large, old tree protections. Lastly, CNW is working with the Forest Service and others to reduce the road system to a more manageable level.

Habitat Connectivity Our Habitat Connectivity Program works to ensure a connected network of habitats that allows for the safe movement of wildlife. This past year we bounded forward with our I-90 Wildlife Corridor Campaign but supporting and publicizing the state's progress on wildlife bridges under and over Interstate 90, features we've long championed through this program. When complete, one of these crossings will be the largest wildlife bridge in North America and will provide safe passage for wildlife and increase habitat connectivity in the Central Cascades Mountains. We have already seen animals using the wildlife undercrossings, and expect use of these passageways to increase in the coming years.

Wolf Recovery Our Wolf Recovery Program evolved in 2016, as we developed better relationships with eastern Washington producer communities and elected officials. Our work led to improvements in field protocols and less legislative drama effecting wolves. Our Range Rider Program is in its fifth year, and we partnered with seven different ranchers who graze cattle on public land within the territory of six different wolf packs. This project demonstrates the effectiveness of non-lethal conflict deterrence methods and promotes social tolerance for wolves in rural communities. Our crew worked with the state write and pass Act 2126, which recognizes the importance of non-lethal measures and local buy-in needed to protect our new wolf population.
